This AMENDMENT TO THE DECLARATION OF RESTRICTIVE COVENANTS FOR WESTFIELD DEVELOPMENT, PHASE X (this "Amendment") is executed to be effective as of the date set forth below by KIELLA DEVELOPMENT, INC (the "Declarant"), a Texas corporation.

#### RECITALS

WHEREAS, KIELLA DEVELOPMENT, INC, a Texas corporation ("Declarant"), filed for record that certain Declaration of Covenants, Conditions, and Restrictive Covenants of Westfield Development, recorded as Document 2004-017987 in the Official Public Records of Bell County, Texas (the "Declaration"), as well as the Declaration of Restrictive Covenants for Westfield Development Phase X, recorded as Document 2015-030088 in the Official Public Records of Bell County, Texas (the "Restrictions"), and made the same applicable to the Property more fully described therein.

AND WHEREAS, Section (45) of the Restrictions provides in relevant part as follows:

"During the Development Period, Declarant, at Declarant's discretion, may alter the Restrictive Covenants, without the joinder of any other Lot Owner",

AND WHEREAS, Article XX of the Declaration allows the Declarant the right to file an amendment to the Declaration or any other Restrictive Covenant for so long as the Declarant is developing the Properties,

AND WHEREAS, the Declarant is currently developing the Properties as defined in the Declaration,

AND WHEREAS, Declarant desires to modify the language of various Sections in the Restrictions,

NOW, THEREFORE, in consideration of the foregoing, the Declarant hereby amends the Restrictions for the above-referenced purposes as follows:

Section (21) is replaced in its entirety with this Section (21):

- (21) Exotic or Dangerous Animals. An "Exotic or Dangerous Animal" is an animal that may pose a safety or health threat to the Owners of the Subdivision, their guest, invitees, Customers or tenants, and includes:
  - (a) dog breeds of pit bull, rotweiler and Doberman pincer, regardless of whether the animal is purebred, a mixed breed or registered with the AKC or similar registration organizations;
  - (b) poisonous insects, amphibians, or reptiles;
  - (c) boa constrictors and other constrictor reptiles;
  - (d) swine
  - (e) animals considered "feral" or wild by nature except guinea pigs, hamsters and gerbils;

and

(f) alligators.

Additional breeds of animals may be added to the definition of Exotic or Dangerous Animals from time to time, as determined necessary by the Association Board members, at their sole discretion, and the Rules and Regulations will be amended to include such breed of animals.


